## Minutes of the 9th meeting of WBSCZMA, to examine the CRZ clearance for the project of bridge over Bidya river proposed by PWD, held on 09.11.20 at the Environment Department, Govt. of West Bengal.

The virtual meeting of WBSCZMA was held on 09.11.20 at the conference room of Environment Department, Govt. of West Bengal, Pranisampad Bhawan, 5th floor, LB - 2, Sector -III, Saltlake, Kolkata.

The Principal Secretary welcomed all the participants and recalled that the project proponent was requested to address certain issues on the proposal i.e. 'Construction of bridge over Bidya river connecting Godkhali and Gosaba Bazar in the district of South 24 Parganas, West Bengal', raised in the earlier meeting held on 28.07.2020. The project proponent had submitted their reply and was asked to give a presentation on it.

Thereafter the project proponent gave a presentation which included the following-

- 1. The diagram of the pier to be put up on the riverbed was submitted. The diameter of the cylindrical pier would be 8.5 m above the riverbed.
- 2. The distance between two piers would be 106 m which is greater than IW AI requirement of 100 m. The proposal has received clearance from IWAI.
- 3. It was confirmed that no mangrove would be cut for the project.
- 4. Three alternative alignments were shown and it was told that alignment 1 (the northern most, passing over confluence of river Bidya with other tributary River Durgaduani) was chosen because it was found to be most environment friendly, as it would entail least cutting of trees and would take minimum time of construction thereby causing least pollution.

After the presentation was over, the following issues were raised by the Expert Members-

- 1. Sandbar formation (along with resulting bank erosion) is a critical factor which needs to be looked into while planning.
- 2. The project area has peculiar geo-morphology where river course and land area change with time.
- 3. It would be prudent to consult Geological Survey of India (GSI) which has done a recent study on the stability of land features in the area under consideration.
- 4. As per the Expert Members, Alignment 2 appeared to be more optimum option rather than Alignment I which had been chosen by the Project Proponent. Alignment 1 is at the confluence of two rivers where the chance of sand deposition is maximum.
- 5. A reputed institute like Riverine Research Institute (RRI) or Indian Institute of Engineering Science & Technology, Shibpur (IIEST) who have expertise in dealing with such projects should be consulted for advice on the width and spacing of the piers for minimising the impact on river flow and adequate bank protection measures.

Project proponent informed the house that they had already approached RRI, a joint field inspection with them is in progress and a report for the same shall be made available shortly to the WBSCZMA.

After detailed discussion, it was decided that RII should be explicitly asked by the project proponent to look into and give their comments/suggestions on the following points -

- i. Formation of sand bars and resulting bank erosion.
- ii. Bank protection measures to be taken up- and down- stream of the river on both sides.
- iii. Out of the three alternative alignments which would be most environmentfriendly and structurally sound, given the peculiar deltaic features of the location.

The meeting ended with thanks to and from the Chair.
