PROCEEDINGS

The Chairman welcomed everybody and initiated the discussion. The Agenda was :

- Consideration for recommendation of CRZ Clearance for proposed project related to setting up of Cryogenic facility for import, storage, handling and Distribution of LPG/Propane/Butane along with allied infrastructure at J.L. No. 140 & 138, Haldia Dock Complex, Mauza : Jagat Chak, Village:Durgachak, Dist : Purba Medinipur, West Bengal - **by Aegis Logistics Limited.**
- The Project Proponent along with their consultant presented the entire project before the Committee through PowerPoint. In course of discussion, it was found that the cryogenic storage facility to be set up for LPG/Propane/Butane was outside the coastal regulation zone. However, as the import was through ship, the transport of the gas from the ship to the storage site had to pass through pipelines being laid out through CRZ- IVB and CRZ-I. The activity was found to be permissible under clause 3(i)(a) and no. 8- I(i)(b) of CRZ Notification, 2011. The pipelines passed through the common corridor of pipelines made for the purpose by KoPT at Haldia. Since the gas comes under hazardous and explosive materials under MSIHC Rules, 1981, a risk analysis report was also submitted by the PP along with approval from Petroleum and Explosives Safety Organization (PESO), Ministry of Commerce and Industries, Government of India for setting up of the project.

Considering all the aspects, **the WBSCZMA unanimously agreed to recommend the above project to Ministry of Environment, Forests and Climate Change (MoEF&CC), Government of India.**

The meeting then ended with a vote of thanks.
